

**Topeka Town Council**

**General Meeting Minutes, October 28, 2019 at 4:05pm**

The meeting was opened with the Pledge of Allegiance.

Council Member Ron Troyer called the meeting to order with Council Member Eash, Council Member Folk, Council Member Kaufman and Clerk-Treasurer Naomi Miller present.

Also, in attendance were Stewart Bender, Cyndi Sadewasser, Bill Eberhard, Stan Strater, Jeremy Sponseller, Harold Gingerich, James McDonald and Trevor Lindsey.

Council Member Folk moved to accept the minutes from October 14, 2019 General Meeting Minutes as written. The motion was seconded by Council Member Eash and passed unanimously.

**Clerk-Treasurer**

Council Member Eash moved to pay all bills as presented. The motion was seconded by Council Member Folk and passed unanimously.

**Town Manager**

A permit is requested for a Lot 4 at Country Squire Estates, a doublewide 1996 Schultz home that was moved into the trailer park 2 years ago without a permit. A Positive Recommendation was recommended by Council Member Kaufman; Council Member Folk seconded the motion and it carried unanimously.

Manager Bender is expecting the agreement from INDOT for the CCMG 2019 outside of a regular scheduled council meeting. Due to the time frame, he is requesting a signature prior to the next meeting. Council Member Folk made a motion for the documents to be approved and signed outside of a council meeting. Council Member Eash seconded the motion and it carried unanimously.

**Town Marshal**

The violation from the Police Department and the invoice from the Fire Department for R. Schrock has been mailed certified return receipt, however no acceptance has been received. Attorney Eberhard said to reissue the documents with a letter from his office allowing Ms. Schrock 10 days to respond, if no response, small claims court.

**Attorney**

A Resolution Establishing a Police Department Take Home Vehicle Program 2019-10-28(a) was presented to the council. Council Member Folk made a motion to approve Resolution 2019-10-28(a); Council Member Kaufman seconded the motion and it carried unanimously.

**Other**

Council Member Eash requested an update on the road projects in Town. Manager Bender updated council on projects in motion.

**Next Meeting**


