## Stewart Bender, Town Manager/Fire Chief

Eric B. Henion; Project Engineer with JPR and Fritz Schlabach, Owner of Rock Run Industries

- Requesting to have a solar field with generators
- They are here about the generator ordinance currently in place for the town
- They feel it won't be smelly or noisy to neighbors
- Generators could run about 4 hours a day on a cloudy day
- Bill Eberhard, Town Attorney stated it would not be the primary source so from the legal standpoint, no ordinance violation
- This is zoned as commercial property
- Neighbor is Keystone RV
- Generator shouldn't kick on at night, they have a battery.
- They could obtain an additional muffler for noise
- Motion to get additional muffler and allow the solar field with generators

#### West Park

- Casey and Stewart shared a quote to upgrade the sidewalks at West Park
- Sidewalks will be ADA compliant
- Cost is \$370,000
- Cost to build a new pavilion with a kitchenette and new restrooms \$396,000 Motion to Approve - Adam Lambright Seconded: Steve Schrock
